Half of yearly tuition on August 1<sup>st</sup> and half on January 1<sup>st</sup> (Discount of 3%) Total Due = \$8,730.00 (\$4,365 per payment)

10 Monthly payments – Aug 1<sup>st</sup> thru May 1<sup>st</sup> @ \$900 per month

12 Monthly payments – June 1<sup>st</sup> thru May 1<sup>st</sup> @ \$750 per month

**Late payments beyond the 15th will incur a 1.5% penalty amount added each month until payment is received.**

ENROLLMENT CONTRACT

In consideration for accepting my child as a student at Bright Beginnings Academy, I do hereby agree to the following: I understand and agree that my obligation is to pay all tuition, fees, and related expenses, as established by the Board of Trustees and itemized in the Tuition and Fee Schedule provided to me at the time of registration for each academic year.

- After August 1, no portion of fees paid will be refunded nor outstanding accounts canceled in the event of absence, withdrawal or dismissal from school of the above student except in the event of extenuating circumstances as approved by the Board of Trustees (in such event an early withdrawal fee equal to at least one month's tuition will apply.)

I understand and agree that in signing this Enrollment Contract for the coming academic year, I am agreeing to accept the rules and regulations of Bright Beginnings as stated in the Parent-Student Handbook. I also understand that my child's enrollment at Bright Beginnings is solely at the will of Bright Beginnings. The school reserves the right to terminate the enrollment of any student if such termination of enrollment is deemed by the administration to be in the best interest of Bright Beginnings. I also understand and agree that my child may be disciplined to include possible suspension or expulsion if he or she refuses to abide by the rules and regulations. In such cases, tuition and fees are NOT refundable.

I further understand and agree that my child may not continue to attend classes if my tuition account is not in good standing. Furthermore, I agree to the policy of the school that no grades and transcripts be released unless all indebtedness has been paid in full.

I understand and agree that by entering this agreement I am authorizing school agents or employees to transport my child to attend school-sponsored trips and activities. The undersigned agrees to release and hold harmless Bright Beginnings, its agents, and employees from all claims, damages, or other liabilities for injuries to my child which are not the result of negligence and/or wantonness by the school, its agents or employees. The undersigned also agrees to indemnify the school for damages by my child.

I understand and agree that in order to reserve a place for my child in a class for the upcoming academic year, this Enrollment Contract must be executed and accepted, and that all applicable fees due at registration must be paid in full.

I understand by entering this contract that any controversy or claim arising out of, or relating to, this contract, or any breach thereof, and/or my child's enrollment, attendance and/or participation at Bright Beginnings shall be settled by binding arbitration administered by the American Arbitration Association in accordance with its applicable rules, and judgment upon the award rendered by the arbitrator may be entered in any court having jurisdiction thereof. I further understand that Bright Beginnings, any provision above notwithstanding, retains the right to pursue all claims for collection of any unpaid balance of tuition, fees or other charges owed pursuant to this contract together with reasonable attorney's fees, expenses and costs, in any court of competent jurisdiction within Mobile County, Alabama, and in such collection actions the laws of the State of Alabama shall govern the interpretation of this agreement.

I understand and agree that the initial term of this Enrollment Contract shall be for one academic year, or any part remaining in the academic year in progress if executed after the first day of classes, and any subsequent renewal shall likewise be for a term of one academic year.
